The evaluation based on price of fuel shall be conducted on 26th of every month. The adjustment (if any) will be valid from first month of each quarter and does not require Supplier's approval. Where there is a difference between the fuel price at the time of evaluation and fuel price stipulated in Article 4.1 hereof, the Service Fee shall be adjusted as follows:

New Service Fee = current Service Fee x (1 + 35% of variation percentage)

At the end of each calendar year, where there is any difference between the CPI at the time of evaluation and the CPI stipulated in Article 4.1 hereof, the Service Fee shall be adjusted as follows:

New Service Fee = current Service Fee x (1 + 65% of variation percentage).

The adjustment (if any) will be valid for the next year and does not require Supplier's approval
